DALLAS (Sept. 9, 2009) – In a scheduled update to its business outlook for the third quarter of 2009, Texas Instruments Incorporated (TI) (NYSE: TXN) today raised and narrowed its expected ranges for revenue and earnings per share (EPS).

The company currently expects its financial results to fall within the following ranges:

- Revenue: \$2.73 – \$2.87 billion, compared with the prior range of \$2.50 – \$2.80 billion
- EPS: \$0.37 – \$0.41, compared with the prior range of \$0.29 – \$0.39.

The company will hold a conference call at 4 p.m. Central time today to discuss this update. This conference call will be available live at www.ti.com/ir. TI's original third-quarter outlook was published in the company's second-quarter 2009 earnings release on July 20, available at www.ti.com/ir. TI's third quarter ends on September 30.
