DALLAS, Sept. 11, 2012 /PRNewswire/ -- In a scheduled update to its business outlook for the third quarter of 2012, Texas Instruments Incorporated (TI) (NASDAQ: TXN) today narrowed its expected ranges for revenue and earnings per share (EPS).

The company currently expects its financial results to be within the following ranges:

- Revenue: \$3.27 3.41 billion compared with the prior range of \$3.21 3.47 billion
- EPS: \$0.38 0.42 compared with the prior range of \$0.34 0.42.

The company will hold a conference call at 4 p.m. Central time today to discuss this update. This conference call will be available live at <u>www.ti.com/ir</u>. TI's original third-quarter outlook was published in the company's second-quarter 2012 earnings release on July 23, available at <u>www.ti.com/ir</u>. TI's third quarter ends on September 30.
