DALLAS (Dec. 8, 2008) – In a scheduled update to its business outlook for the fourth quarter of 2008, Texas Instruments Incorporated (TI) (NYSE: TXN) today lowered its expected ranges for revenue and earnings per share (EPS).

The company currently expects its financial results to fall within the following ranges:

- \cdot Revenue: \$2.30 2.50 billion, compared with the prior range of \$2.83 3.07 billion
- EPS: \$0.10 0.16, compared with the prior range of \$0.30 0.36.

The company will hold a conference call at 4:30 p.m. Central time today to discuss this update. This conference call will be available live at www.ti.com/ir. TI's original fourth-quarter outlook was published in the company's third-quarter 2008 earnings release on October 20, available at www.ti.com/ir. TI's fourth quarter ends on December 31.
